



What sort of topics would interest you enough to make you come to a meeting?


Would you like to attend half day or full day seminars on topics that would benefit you at work?

Musings of a Consultant



I have storage on my mind of late.

On my desk I now have a RAID 1 NAS system for business files, a modest unit by today's standards of only 750 GB (mirrored). But stations today have terabytes hanging on their news editing systems, their playout servers, near line spinning disk, and often in robotic archives. As tape slowly fades out, storage is growing by leaps and bounds. Add it all up and there is a lot of storage being sold to broadcasters.

The grand shame in all of this is that it is seldom a well-managed and purposeful strategy with goals that must be achieved. Worse, it is often the result of a "turf war" with different departments vying for control of their own storage because only they know what is REALLY needed to protect their unique content.

As an industry, we need to embrace storage as a utility function provided across a facility, or indeed distributed among stations in a group. Who owns and controls the pool of resources should not matter. What matters is that the goals are carefully articulated and a coherent strategy is developed which maximizes access, minimizes cost, and provides the appropriate level of security for all content.

FCC Report

FCC LIFTS FREEZE ON MAXIMIZATION APPLICATIONS

Window Closes June 20, 2008

The FCC recently released a Public Notice lifting the freeze on DTV maximization applications and petitions for rulemaking to amend the DTV Table of allotments to specify substitute channels. All applications or channel substitution proposals filed from May 30 through June 20, 2008 will be treated as though filed on the same day, so there is no advantage to an early filing during this window.

Previously-filed applications that included freeze waiver requests will be treated as though filed during this window.

Licensees that have pending petitions for reconsideration of the DTV Table should file maximization applications rather than rely on approval of their petitions in order to preserve their maximization prospects.

Petitions for allotment of DTV channels for new stations or for changes in community of license will not be accepted at this time.

In a novel approach to processing, the Commission will not prefer one mutually exclusive proposal over another filed during the window. Rather, it will grant any otherwise technically acceptable conflicting applications subject to the condition that "the applicants resolve their mutual exclusivity within 30 days of the grant." If such agreements are not made, the construction permits will be cancelled and the applicants will be required to file fresh applications if they want to continue to pursue maximization.

After the window, applications will be processed on first-come, first-served basis.

It should be noted that maximization proposals will not by themselves extend underlying construction deadlines. Licensees must be prepared to meet all currently applicable deadlines.
